Dear Mr. Shankar:

By letter dated January 22, 2001, the Electric Power Research Institute (EPRI) requested a waiver of the fees under Footnote 4 of 10 CFR 170.21(J) for the review of EPRI Topical Report, "Guidelines for Electromagnetic Interference (EMI) Testing in Power Plant Equipment, TR-102323, Rev. 2." Your request was denied by the NRC Chief Financial Officer's (CFO) letter dated February 14, 2002. On April 25, 2002, EPRI sent a letter to the NRC's CFO requesting the decision to be reversed.

In a January 15, 2003, phone conversation with Ellen Poteat of the CFO staff, Mr. Gary Vine, EPRI, agreed to write a letter to the Commission appealing the decision. However, due to the inactivity of the staff's review of this topical report for almost 2 years, TAC No. MB1036 is being closed. A resubmittal of the topical report will be required to open a new TAC number.

As provided in 10 CFR 170.5 and 171.9, please send all future correspondence regarding NRC fees to: Chief Financial Officer, U.S. Nuclear Regulatory Commission, Washington, DC 20555-0001. In addition, to assist NRC in making timely decisions on future fee waiver requests, it is requested that any topical report for which EPRI seeks a fee waiver under criterion (c) of Footnote 4 of 10 CFR 170.21(J), include a statement indicating the purpose for which the report is being submitted. Prior to commencing the technical review of the submittal, the NRC will notify EPRI whether the fee waiver is granted or denied. In this manner, in the event the waiver is denied, EPRI will have an opportunity to determine if it wants to withdraw the request prior to costs being incurred which must be billed to EPRI.
