It also requested, consistent with the NRC Office of Nuclear Reactor Regulation Instruction LIC-500, "Processing Requests for Reviews of Topical Reports," that the NRC provide an estimate of the review hours, as well as target dates for any requests for additional information (RAIs) and for completion of the safety evaluation (SE) for the TR.

The NRC staff has performed an acceptance review of WCAP-15831-P, Revision 0. We have found that the material presented is complete enough to begin a review. The staff expects to issue RAIs by March 31, 2003, and complete its review by December 31, 2003. It is estimated that the review will require approximately 800 staff hours. The review hour estimate does not include time required to coordinate the review and develop and issue the SE.

Section 170.21 of Title 10 of the Code of Federal Regulations requires that TRs are subject to fees based on the full cost of the review. You did not request a fee waiver; therefore, staff hours will be billed accordingly. To enable us to complete this review on schedule, close and frequent communications between our technical staffs will be required.
