NRC staff have informed me that the State of California became an Agreement State, that is a state that has signed an agreement with the NRC authorizing the state to regulate the use of radioactive materials within state, on September 1, 1962. Staff was able to determine that the company EG&G, Inc., Goleta, CA, held license number SNM-682, Docket No. 070-00708, which was terminated on 03/31/79. Staff has further indicated that records (radiation exposure records, radioactive contamination records or survey records, and any remedial procedures/cleanup records) regarding an incident on or about March 27, 1983, would be held by the State of California.
