Licensee Response to the Order for Compensatory Measures Related to Access Authorization

Dear Ms. Vietti-Cook:

By letter dated January 7, 2003, Southern Nuclear Operating Company ("SNC") received the subject Order for Compensatory Measures Related to Access Authorization for the Edwin I. Hatch Nuclear Plant (HNP); the Joseph M. Farley Nuclear Plant (FNP); and the Vogtle Electric Generating Plant (VEGP). SNC recognizes the modifications that the Order has made to the Operating Licenses for HNP, FNP and VEGP.

The Order of January 7, 2003 modifies the licenses authorizing operation of nuclear power plants in accordance with the Atomic Energy Act of 1954 and Title 10 of the Code of Federal Regulations (10 CFR), Part 50. Section III.A of the Order requires licensees to begin implementation of the requirements described in Attachment 2 of the Order immediately and to completely implement the requirements by April 7, 2003; July 7, 2003; and January 7, 2004, respectively. Section III.C requires SNC to provide the Commission with a Schedule for achieving full compliance with the requirements of Attachment 2 to the Order by that date. In accordance with the Order and 10 CFR 50.4, SNC is submitting the attached Response and Schedule for Achieving Compliance with the Order for each of the above-mentioned licensed facilities within the requisite 20 days.¹ This Response and Schedule for Achieving Compliance contains safeguards information.


