The purpose of this modification is to provide incremental funding in the amount of \$40,000 for Option Year Two hereby increasing the obligated amount from \$840,000 to \$880,000. Accordingly, the contract is hereby modified as follows:

Under Section B.3, paragraphs (i) and (j) are deleted in their entirety and replaced with the following:

- “(i) The amount currently obligated by the Government with respect to this contract is \$880,000 of which the sum of \$814,340.74 represents the estimated reimbursable costs and the sum of \$65,659.26 represents the fixed fee.
- (j) It is estimated that the amount currently allotted will cover performance through February 28, 2003 ”

All other terms and conditions of the subject contract, including the contract ceiling amount of \$1,207,460.00, remain unchanged.

This modification obligates FY 03 funds in the amount of \$40,000.
