

The purpose of this modification is to deobligate funds in the amount of \$15,131.00, decreasing the obligated amount from 115,000.00 to \$99,869.00. Accordingly the contract is hereby modified as follows:

Under **Section B.10, CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988)**, the first sentence of paragraph (b) is deleted in its entirety and replaced with the following.

“(b) The amount presently obligated with respect to this contract is \$99,869 00.”
