Dear Mr. Holonich:

Power Resources, Inc. (PRI) requests an amendment to the above referenced Source Material License to allow the operation of the Gas Hills ISL Project. It is proposed to operate the Gas Hills Project as a wellfield and ion exchange Satellite operation to the Highland Uranium Project. As such, PRI is proposing to extract uranium from the mineralized aquifer utilizing the ISL technique. The uranium will be removed from the ground water by ion exchange at the Satellite facility. The uranium bearing ion exchange resin will be transported in specially built transport trailers to the Highland Uranium Project where the resin will be eluted and the uranium processed into yellowcake.

To support this amendment request, PRI is submitting a Form 313, "Application for Material License" and three copies of the following supporting information:

- Volume 1: Contains 11 chapters formatted in accordance with Regulatory Guide 3.46 and provides the technical basis for the amendment request.
- Volume 2: Contains WDEQ Appendix D5, "Geology", which supports Chapters 2 and 3 of Volume 1.
- Volume 3: Contains WDEQ Appendix D6, "Hydrology", which supports Chapters 2 and 3 of Volume 1.
- Volume 4: Contains WDEQ Appendix D7, "Soils", D8, "Vegetation", D9, "Wildlife" and D11, "Wetlands", which support Chapters 2 and 3 of Volume 1.
- Volume 5: Contains Appendix 12, "Mildos Evaluation" which supports Chapter 7 of
