We were unable to locate any more recent license for this company. However, in April 1992, NRC relinquished part of its regulatory authority to the State of Maine. It is possible that Bigelow now holds a radioactive materials license issued by Maine. To pursue this possibility you should contact the State of Maine, Radiation Control Program.
