Dear counsel for CPUC:

Robert Temple's motion of even date requests that the Atomic Safety and Licensing Board grant the request of three admitted participants under 10 CFR 2.715(c), plus the California Public Utility Commission, to file joint responses to the pending interrogatories and requests for documents. The participants also move that the expert(s) that they identify in their interrogatory responses be considered the experts of all of the section 2.715(c) participants.
