Re-submittal of Request for Renewal of the Certificate of Compliance

Dear Dr. Travers:

This letter re-submits Public Service Company of Colorado's (PSCo) request for renewal of Certificate of Compliance No. 6346 for the Model FSV-1 package. PSCo owns and maintains two of the FSV-1 casks, and General Atomics (GA) owns and maintains one FSV-1 cask. Certificate of Compliance No. 6346 has an expiration date of April 30, 1996. Both PSCo and GA desire to continue using the FSV-1 casks for shipment of radioactive material.

In support of this renewal request, a copy of the Consolidated Design Report for the Model FSV-1 Shipping Cask, GADR-55, Revision B, is enclosed for your information. GADR-55 is the Safety Analysis Report for the package, and this submittal reflects two revisions to the Certificate of Compliance since its last renewal: Revision 23 dated June 23, 1992, and Revision 24 dated November 30, 1994.

The attached copy of GADR-55 has been revised since the February 29, 1996 submittal (see the referenced letter) to reflect a change to bolt load numbers in section 2, that had previously been approved but were inadvertently omitted from Revision A to GADR-55. In addition, clearer copies of several figures were provided and revision markers were included. This letter completely replaces PSCo's February 29, 1996 submittal and we request that you discard copies of GADR-55, Revision A, that were previously submitted.
