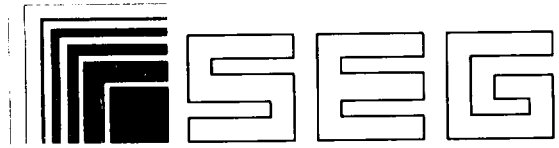

Mr. MacDonald:

This letter requests that the above referenced Certificate of
Compliance be renewed. Enclosed are eight (8) copies of the
following for your review:

"3-82B Cask Certification Drawing,"
Scientific Ecology Group Drawing No. STD-02-076, Rev. 7

"Safety Analysis Report for the 3-82B Radwaste Shipping Cask,"
Scientific Ecology Group Document No. STD-R-02-014, Rev. 7

The above documents comprise the consolidated application for
renewal of this Certificate of Compliance. With the exception of a
name change and minor hardware changes being incorporated for the
convenience of operation, no changes have been made to the
qualification analysis or other commitments made in earlier
revisions of these documents.

The cask has been renamed from the HN-200 to the 3-82B to reflect
the cask designations used by Scientific Ecology Group, Inc.

In addition to the name change, the drawing has also been revised
to reflect minor hardware changes to the cask. The drawing was
revised to add optional dust seals between the cask and the upper
impact limiter. The detail for the attachment of the impact
limiters to the cask has been changed to eliminate the pear-shaped
link between the limiter and the turnbuckle and have the turnbuckle
attach directly to the limiter. The final change to the drawing was
to make the threads in the lead plug in the cask lid optional.

These changes do not adversely affect the safe operation of the cask and no changes to the cask Safety Analysis Report resulted from them.


The revisions made to the Safety Analysis Report in this renewal request address only the change in the cask designation to 3-82B and references to Scientific Ecology Group, Inc.

The \$150.00 application fee associated with the processing of this revision to the Certificate of Compliance is enclosed with this letter.

In making this consolidated application, we respectfully request a 60-day period following issue of the revised Certificate of Compliance to allow us to incorporate the hardware and nameplate changes associated with this submittal.
