DOE RELEASES ENVIRONMENTAL IMPACT STATEMENT  
FOR RIFLE, COLORADO MILL TAILINGS SITES

The U.S. Department of Energy (DOE) has issued a draft Environmental Impact Statement (EIS) concerning the cleanup of uranium mill tailings and other materials from the Old and New Rifle uranium mill tailings sites in Rifle, Colorado. The Environmental Protection Agency (EPA) Notice of Availability of the draft EIS will be published in the Federal Register May 29, 1987.

The draft EIS is being made available for public review and comment, after which a final EIS will be published and an official Record of Decision will be issued stating the chosen remedial action alternative.

The draft EIS for the Rifle mill tailings examines four remedial action alternatives:

1. No action
2. Stabilization of both old and new piles at the New Rifle site
3. Disposal at the Estes Gulch site (Preferred Alternative)
4. Disposal at the Lucas Mesa site.

The EPA standards for cleanup of inactive uranium mill tailings sites cannot be met under the "no action" option. Impacts associated with Alternatives 2, 3, and 4 were evaluated in terms of radiation, air quality, soils, mineral resources, surface water and ground-water quality, ecology, land use, noise, social and economic impacts, and transportation networks. Both short-term (during remedial action construction) and long-term (stabilization for hundreds of years) impacts were assessed.

Estimated costs, in 1986 dollars, for remedial action alternatives at Rifle vary from \$13.9 million to \$53.9 million.

The final course of action by the DOE with respect to these alternatives will be based on analyses to be reported in the final EIS. The final ruling will be announced in a Record of Decision not less than 30 days after the final EIS is issued.

This activity is being carried out under the Uranium Mill Tailings Remedial Action (UMTRA) Project, managed by the DOE from the UMTRA Project Office in Albuquerque, New Mexico. The DOE will hold a public hearing to allow interested groups and individuals an opportunity to comment on the contents of the draft EIS. The hearing will be held at 2 p.m. and reconvene at 7 p.m. on June 11, 1987, at the Rifle City Council Chambers, Rifle City Hall, 202 Railroad Avenue, in Rifle. Transcripts of this hearing will be made available by the DOE. The DOE will provide additional public notice prior to the formal public hearing.
