Dear Mr. Meyer:

In accordance with Section G.4 of the subject contract entitled "Task Order Procedures," this letter definitizes Modification No. 3 to Task Order No. 1 which (1) increases the level of effort by 400 professional hours to allow the contractor to resolve comments received from a peer review of the draft report concerning the regulatory effectiveness of the resolution of the generic safety issue USI: A-45, and incorporate comments in the report, if appropriate, (2) increases the task order ceiling and obligated amounts by \$48,167.21 from \$152,594.00 to \$200,761.21; (3) extends the period of performance of the subject task order until March 29, 2003; and (4) revises the completion date for the issuance of the Final Report from "December 31, 2002" to "March 29, 2003". The effective date of this modification is February 6, 2003. Therefore, any work performed during the period of January 1, 2003 through February 5, 2003 will not be reimbursed. Accordingly, the task order is hereby revised as follows:

The second paragraph of the definitization letter of the basic task order is deleted in its entirety and the following is substituted in lieu thereof.

"Task Order No. 1 shall be in effect from August 31, 2001 through March 29, 2003, with a cost ceiling of \$200,761.21. The amount of \$186,754.71 represents the total estimated reimbursable cost, and the amount of \$14,006.50 represents the fixed fee."


