Dear Mr. Couch:

The purpose of this modification is to provide for a downward adjustment of the task order ceiling to reflect a decrease in the level of effort. As a result of this action, the ceiling amount is decreased by \$234,315.13 from \$578,175.00 to \$343,859.87.

Accordingly, the following changes are hereby made:

"Task Order No. 1 shall be in effect from April 3, 2000 through February 15, 2002, with a cost ceiling of \$343,859.87. The amount of \$316,629.73 represents the reimbursable costs, and the amount of \$27,230.14 represents the fixed fee.

The amount presently obligated with respect to this task order is \$343,859.87 of which the amount of \$316,629.73 represents the reimbursable costs, and the amount of \$27,230.14 represents the fixed fee."

Please indicate your acceptance of this modification by having an official who is authorized to bind your organization, execute three copies of this document in the spaces provided on page two (2) and return two copies to the Contract Specialist. You should retain the third copy for your records.

In addition, the subject task order expired on February 15, 2002, and closeout action has been initiated. If negative reports are appropriate, statements to that effect are required.




