The purpose of this modification is to revise Paragraph B.4 - Consideration and Obligation, Subparagraph (b), to provide incremental funding in the amount of \$150,000.00, thereby increasing the obligated amount of the subject contract from \$1,895,443.40 to \$2,045,443.40.

Accordingly, the following change is hereby made:

1. Under Section B - Supplies or Services and Prices/Costs, Paragraph B.4 - Consideration and Obligation, Subparagraph (b) is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.4 CONSIDERATION AND OBLIGATION

- (b) The amount currently obligated by the Government with respect to this contract is \$2,045,443.40 of which the sum of \$1,931,557.74 represents the reimbursable costs and of which \$113,885.66 represents the fixed fee."

This modification obligates FY03 funds in the amount of \$150,000 00.
