

The purpose of this modification is to deobligate excess funds in the amount of \$1,071.72 from the subject contract, thereby decreasing the obligated amount from \$32,980.00 to \$31,908.28. Accordingly, the following changes are hereby made:

- 1. Subsection B.3 <u>Consideration and Obligation -- Time and Materials/Labor Hour</u>, is hereby deleted in its entirety and the following is substituted in lieu thereof the following:
 - "B.3 Consideration and Obligation Time and Materials/Labor Hour
 - a. The total estimated cost to the Government for performance under this contract for the basic contract and Option year 1 (2nd Year) is \$31,908.28.
 - b. The amount obligated by the Government with respect to this contract is \$31,908.28.

This modification deobligates \$1,071.72.
