The purpose of this Modification No. 7 to contract no. NRC-02-00-010 is to exercise the contract option, in accordance with Section I.5 OPTION TO EXTEND THE TERM OF THE CONTRACT. Therefore, the following changes are hereby made:

1. Section B.3 CONSIDERATION AND OBLIGATION --- TASK ORDERS, paragraph (a), is revised to increase the Maximum Ordering Limitation by \$1,178,580.00 from \$3,206,922.00 to \$4,385,502.00. The Maximum Ordering Limitation \$4,385,502.00 covers the performance of work during the contract one-year base period, Option Year 1, Option Year 2 and Option Year 3. The Maximum Ordering Limitation for the one-year base period is \$948,187.00. The Maximum Ordering Limitation for Option Year 1 is \$1,113,282.00. The Maximum Ordering Limitation for Option Year 2 is \$1,145,453.00. The Maximum Ordering Limitation for Option Year 3 is \$1,178,580.00. All other terms and conditions under Section B.3 remain the same.

2. Section F.6 DURATION OF CONTRACT PERIOD is revised to read as follows:

"The ordering period for this contract shall commence on March 3, 2000 and will expire on March 2, 2004. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the Government for an additional 1 one-year period."

All other terms and conditions of the contract remain the same.
