Dear Ms. Hwang:

In accordance with the task order procedures of the subject contract, this letter definitizes Modification No. 4 to Task Order No. 13. The level of effort for Task Order No. 13 is hereby increased to allow for contractor's review of additional comments received on the draft letter report, titled "Assessment of the Relative Risks Across the Life Cycle of Commercial Spent Nuclear Fuel", in preparation of the final report. As a result, the cost ceiling for Task Order No. 13 is increased by \$6,322.91 from \$93,266.01 to \$99,588.92. The sum of \$92,211.96 represents the reimbursable costs and the sum \$7,376.95 represents the fixed fee.

This Modification No. 4 extends the Period of Performance for this task order through February 28, 2003.

This Modification No. 4 obligates funds in the amount of \$6,000.00 under this task order. Accordingly, the total amount obligated under Task Order No. 13 is hereby increased from \$93,266.01 to \$99,266.01. The accounting data for the obligated funds is as follows:


