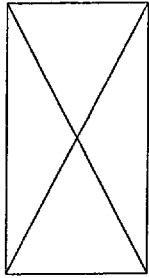

Ladies and Gentlemen:

As previously arranged with your office, Cabot Performance Materials is submitting via the electronic deliverable process its application for renewal of license SMB-920 for operations at our Boyertown, Pennsylvania site. You will receive our application in two sections. The first section includes this letter and the attached NRC Form 313. Together they provide the certifying officer's signature required at the bottom of NRC Form 313 and they confirm that the statements and commitments given in the application are fully supported by the management of Cabot Performance Materials. The second section is the supporting information that describes the operations, organization, and programs that compose our radiation protection systems. That submittal will be sent separately, with our full review and support, by our consultant at WESTON Solutions, Inc.

Cabot has recently strengthened its EHS Department in order to advance our programs and regulatory compliance to exemplary levels. Although the processes in our plant and most of our radiological procedures remain basically unchanged, our radiation safety programs have been modified to provide higher levels of management and employee involvement, and to strengthen our continuous improvement process. The information in our application will, therefore, replace the information provided for previous licenses with the exception of the detailed procedures for monitoring and analyzing radiological conditions. Those procedures remain in place as reviewed and agreed upon with inspectors from the Region 1 office of the NRC in King of Prussia, PA. Our objective is to clarify and simplify the documentation of our current programs by comprehensively describing their current status. Please contact our RSO, Mr. Knapp, for any additional information. Thank you for your consideration.
