As requested, we have reviewed the proposed revisions to the Mississippi State Department of Health's *Regulations for Control of Radiation in Mississippi*, Part 801, Section W, Radiation Safety Requirements for Wireline Service Operations and Subsurface Tracer Studies, dated January 23, 2003. The proposed regulations are in response to the two amendments identified in the enclosed State Regulation Status (SRS) Data Sheet. The regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Parts 34, 36 and 39. We discussed our review of the regulations with you on February 27, 2003.

As a result of our review, we have enclosed one comment. Please note that we have limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that a State regulation meets the compatibility and health and safety categories of the equivalent NRC regulation may only be made based on a review of the final State regulation. However, we have determined that if your proposed regulations were adopted incorporating our comment and without significant change, they would meet the compatibility and health and safety categories established in Office of State and Tribal Programs (STP) Procedure SA-200.

We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in STP Procedure SA-201, *Review of State Regulatory Requirements* (November 10, 1998), please highlight the final changes and send one copy to STP.
