1 compensation for services rendered and reimbursement of expenses incurred during the
2 Application Period.

3 2. The Firm billed a total of \$99,513.40 in fees and expenses during the
4 Application Period. The total fees represent 303.30 hours expended during the period covered by

14 first class mail, postage prepaid, on or about February 26, 2003.


15 9. The interim compensation and reimbursement of expenses sought in this
