20 PLEASE TAKE NOTICE that the Notice of Hearing on Interim Compensation
21 Applications of Professionals and Final Expense Application of Creditors' Committee Members
22 ("Hearing Notice"), dated January 16, 2003, incorrectly stated the amount of interim
23 compensation sought by Deloitte & Touche LLP ("Deloitte"), Independent Auditor, Accountant,
24 Tax Advisor and Consultant to Debtor Pacific Gas and Electric Company ("Debtor"). Exhibit A
25 to the Hearing Notice incorrectly indicated that the fees requested by Deloitte for the period from
26 August 1, 2002, through November 30, 2002, are \$1,335,451.19. The correct amount of fees
27 requested by Deloitte's third interim compensation application, filed on January 13, 2003, was
28 \$1,724,020.50. Since the filing of Deloitte's third interim compensation application, Deloitte

2 correctly stated the amount of cost reimbursement requested by Deloitte.)
