3 2. The Firm billed a total of \$768,865.34 in fees and expenses during the Application

Any interim fees or reimbursement of expenses approved by this Court and received by the Firm (along with the Firm's retainer) will be credited against such final fees and expenses as may be allowed by this Court.

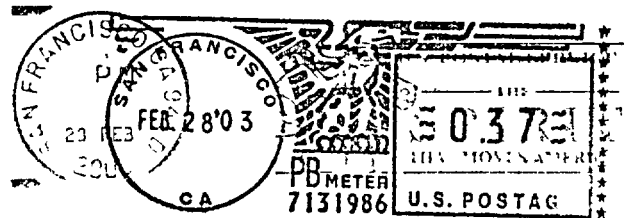
