LEARNED TASK FORCE RECOMMENDATIONS

The purpose of this memorandum is to forward for your information the plans for implementing the recommendations that resulted from the staff's Davis-Besse Lessons Learned activities, as directed by a Staff Requirements Memorandum dated January 21, 2003.

The overall plan was jointly developed by the Office of Nuclear Reactor Regulation (NRR) and the Office of Nuclear Regulatory Research (RES). The plan includes four action plans to address, as a minimum, the high priority recommendations in each of the overarching groups identified by the Senior Management Review Team. The plan also includes a review of the lower priority recommendations using the PBPM process to assign lead responsibility and completion schedules. Finally, the plan establishes a mechanism for providing semiannual reports on the status of implementation of each recommendation, which will be forwarded to the Commission for information.

I have directed NRR and RES to proceed with implementation of the plans. It should be noted that many action plan activities are already in progress as part of the Agency's response to the Davis-Besse head degradation event.
