The purpose of this modification is to revise article V. DURATION OF AGREEMENT, by extending the agreement for ninety (90) days.

Accordingly, the Interagency Agreement (IA) is revised as follows:

In accordance article V. entitled "DURATION OF AGREEMENT," the NRC and NIH hereby revise the agreement period. Therefore, article V. DURATION OF AGREEMENT, is deleted entirely and the following is substituted in-lieu thereof.

**"V. DURATION OF AGREEMENT:**

This agreement will be effective on October 1, 2001 and continue through March 31, 2003 (FY2003). This agreement may be extended to continue these services during subsequent fiscal years by mutual agreement. The process for any extension will be by NRC initiating a written request for NIH to accept a modification of this agreement to include coverage for the extension period, and NIH accepting the modification. In the event either agency intends to terminate this agreement, that agency will notify the other agency at least 60-days prior to the intended date of the termination "
