SUBJECT: U.S. NUCLEAR REGULATORY COMMISSION REVIEW OF THE QUAD CITIES

NUCLEAR POWER STATION LICENSE RENEWAL APPLICATION

Dear Ms. Keo:

The U.S. Nuclear Regulatory Commission (NRC) is seeking input for its environmental review of an application from Exelon Generation Company, LLC (Exelon) to renew its operating license for the Quad Cities Nuclear Power Station, Units 1 and 2 (QCNPS), located in Rock Island County, Illinois. QCNPS is in close proximity to lands that may be of interest to the Sac & Fox Nation. As described below, the NRC process includes an opportunity for public participation in the environmental review. We want to ensure that you are aware of our efforts and, pursuant to 10 CFR 51.28(b), the NRC invites the Sac & Fox Nation of Missouri in Kansas and Nebraska to provide input to the scoping process relating to the NRC's environmental review of the application.

The NRC will hold public scoping meetings for the QCNPS license renewal supplement to the NRC's "Generic Environmental Impact Statement for License Renewal of Nuclear Plants" (GEIS) (NUREG-1437). These scoping meetings will be held at the The Mark of the Quad Cities, 1201 River Drive, Moline, Illinois, on April 8, 2003. There will be two sessions to accommodate interested parties. The first session will convene at 1:30 p.m. and will continue until 4:30 p.m., as necessary. The second session will convene at 7:00 p.m., with a repeat of the overview portions of the meeting, and will continue until 10:00 p.m., as necessary. Additionally, the NRC staff will host informal discussions one hour before the start of each session. No formal comments on the proposed scope of the supplement to the GEIS will be accepted during the informal discussions. To be considered, comments must be provided either at the transcribed public meetings or in writing. The application and the environmental review process are described below.

Under NRC regulations, the original operating license for a nuclear power plant is issued for up to 40 years. The license may be renewed for up to an additional 20 years if NRC requirements are met. The current operating licenses for QCNPS will expire in 2012. Exelon submitted an environmental report as part of its application for renewal of the QCNPS operating license on January 3, 2003. The application is electronically available for inspection from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS). ADAMS is accessible at http://www.nrc.gov/reading-rm/adams.html, which provides access through the NRC's Public Electronic Reading Room (PERR) link.
