The team was comprised of staff from OIP and the three major program offices. Two days were spent in Cologne and two days at the former Julich Nuclear Research Center.  The agenda included briefings on the overall High Temperature Reactor (HTR) program, safety analysis of HTR Module design, fuel element research /development (R&D) and industrial production, pebble bed heat transfer and fluid flow, core physics, pebble flow, nuclear graphite, waste management, AVR and THTR reactor test programs, safety assessments and operational experience, HTR rules and standards and technology transfer to Eskom of South Africa.  Briefings were conducted by representatives of the Julich R&D Center, two reactor design organizations, the standards setting organization (KTA), two organizations performing technical safety evaluations (TUV), the utility operating THTR and the state licensing authority for THTR.
