Dear Ms. Beckman

The purpose of this modification is to add one Electrical Systems Design Specialist who shall participate in all inspection activities as stated in the original Statement of Work, with the exception of the inspection preparation that took place 1/27/03 through 1/31/03. As a result of adding this Specialist, the estimated level of effort is increased by 150 hours, from 194 hours to 344 hours, thereby, increasing the task order ceiling and obligated amounts. Therefore, the task order ceiling and obligated amounts are increased by \$21,546.87 from \$29,182.04 to \$50,728.91. Accordingly, the following changes are hereby made:

"Modification No. One is effective January 31, 2003. Task Order No. 138 shall be in effect from January 24, 2003, through March 14, 2003, with a cost ceiling of \$50,728.91. The amount of \$49,132.12 represents the estimated reimbursable costs, and the amount of \$1,596.79 represents the fixed fee. Funds in the amount of \$21,546.87 are obligated by this modification. This task order is fully funded."


