

The purpose of Modification No. 1 is to: a) Revise Section B.1.3 to reduce the scheduled hours of the Principal Technical Advisor by 52.63 from 1,860 to 1,807.37; b) Add a line item for travel to provide for 4 trips to NRC Headquarters during the contract Base Year; c) Revise Section C, paragraph XVI., to remove the specified hours of operation, location of work and the requirement to complete a sign in sheet; and d) Obligate funds. Accordingly, the following changes are made:

1. Section B.1.3. SCHEDULE is revised to read as follows:

"The Contractor shall provide services to the NRC in accordance with the PERFORMANCE WORK STATEMENT for the contract period of performance at the rates set forth below.

2. Section C, paragraph XVI. Hours of Operations, is revised to read as follows:

"The contractor personnel shall work eight (8) hours per day, five (5) days a week. The Contractor shall be paid only for the hours the contractor employee's perform work."

3. Section B 2, paragraph (b), is revised to read as follows:

"(b) The amount presently obligated with respect to this contract is \$191,455.00. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."
