Part 72, to make clear that licensing is allowed only for federally owned and operated away-fromreactor spent nuclear fuel ("SNF") storage facilities and not for an away-from-reactor storage facility that is privately owned. The requested amendment is necessary to bring Part 72 into conformity with the Nuclear Regulatory Policy Act of 1982, as amended, 42 U.S. C. §§ 10101 et seq. The Petition for Review was filed by Petitioners for review of the NRC Memorandum and Order to the extent the Memorandum and Offder denied the Petition to Institute Rulemaking filed before the NRC on February 11, 2022.
