DELAY IN PROCESSING REPORT DUE TO AWAITING CELLULAR PHONE LISTING. GROVER'S JUN-AUG 96 CALLS DO NOT APPEAR QUESTIONABLE. THE OTHER NON-SPECIFIC COMPLAINT WAS DATED AS WELL. ZERO.

SYNOPSIS

An anonymous male telephonically contacted the OIG Hotline and advised as follows. Caller advised Ron Grover (subsequently identified as Manager, Chemical and Environmental Protection, Nuclear Operations) uses TVA materials, telephone system to include cellular phones, and TVA vehicles for personal use. Caller also stated Grover has set up a contract within a contract through a personal service contract for a friend (Leo Ryan, President of Fintech) to do work at SQN and WBN. This work was done by Fintech but it was work that was not required by the site. The contract was initially set up through Calgon. Since TVA is in such an efficiency mode this was a waste of a quarter of a million dollars. Caller could not provide any more information nor could he give specific dates other than the fact the Fintech contract took place approximately two years ago.

Caller stated Grover as of October 1996, is on loan to a company called INPO.
