On August 9, 2002, the U.S. Nuclear Regulatory Commission (NRC) issued Bulletin 2002-02, "Reactor Pressure Vessel Head and Vessel Head Penetration Nozzle Inspection Programs," to the industry requesting that licensees operating pressurized water reactors (PWRs) provide information related to their reactor pressure vessel (RPV) head and vessel head penetration (VHP) nozzle inspection programs for their respective facilities. On February 11, 2003, the NRC issued an immediately-effective order to PWR licensees establishing interim inspection requirements for RPV heads. These enhanced inspection requirements supplement the existing inspection and other requirements in the American Society of Mechanical Engineers Boiler and Pressure Vessel Code and NRC regulations. Plant-specific TAC numbers have been opened for activities associated with the order requirements. As such, the NRC requirements imposed by the order supersede all activities associated with Bulletin 2002-02.
