Dear Sir:

A new application for registration of the Envionics USA Inc Chempro 100 was previously submitted and approved. We are requesting the following changes be incorporated into an amendment to the device registration. Except for the following changes, previous commitments for the Chempro and its distribution shall be honored by Envionics USA .

Other than following, no changes, particularly to the device design, quality assurance/control, distribution commitments have been made since last application for registration. The device and distribution are unchanged except for:

1. The phillips screws that are used to attach the belt clip will add the torx screw already used as an alternate part for producibility purposes; see attached drawing with the screws highlighted and spec sheet.
2. The label on the front marked Chempro will be removed to allow for branding of the device for specific markets (i.e. Drager MultiIMS for the Firefighters, etc.). See attached figure. All radiation labeling is unchanged. Specific labels will be added for the specific customer or market prior to shipment similar to the smoke detector market. This does not impact the safety or the operation of the device.
3. Add new facility located at 4420 Eastport Parkway, Port Orange, FL 32127 to block 12 of license as an additional distribution point.
