SUBJECT: STAFF REQUIREMENTS - SECY-03-0030 - PROPOSED  
AGREEMENT BETWEEN THE STATE OF WISCONSIN AND  
THE COMMISSION PURSUANT TO SECTION 274 OF THE  
ATOMIC ENERGY ACT OF 1954, AS AMENDED

This is to advise you that the Commission has not objected to publication of the proposed agreement with the State of Wisconsin in the Federal Register for public comment, subject to the changes noted below.

Changes to the Draft Assessment:

1. On page 1, paragraph 2, line 3, insert a comma after "Public Health".
2. On page 2, 1<sup>st</sup> paragraph under item 2., revise the next to last line to read ' ... the Wisconsin rules **also** apply in
3. On page 3, revise line 5 from the top to read ' ... license as an **alternative** alternate to license ....'
4. On page 3, 2<sup>nd</sup> full paragraph, line 2, delete the comma after "1403". Delete the 3<sup>rd</sup> sentence (The manner in which ... as NRC.) and replace it with: The State need not address the essential objectives in the same manner as the NRC.
5. On page 3, 3<sup>rd</sup> full paragraph, line 10, insert a comma after "Agreement". Revise line 12 to read ' ... similar to Ohio's **approach**.'
6. On page 4, paragraph 3, revise the last line to read ' ... radioactivity are **consistent** ~~uniform~~ with those in ....'
7. On page 4, paragraph 2 under item 4., revise line 5 to read ' ... medical procedures. **Like As with** NRC ....'
8. On page 8, 1<sup>st</sup> full paragraph, line 1, delete the comma at the end of the line.

9. On page 8, last paragraph, revise line 6 to read ‘ ... licensing procedures guides ....’
10. On page 9, paragraph 2 under item 15., next to last line, insert a comma after “period”.
11. On page 9, last paragraph, revise the last line to read ‘ ... ~~those~~ in NRC procedures.’
12. On page 10, paragraph 2 under item 17, line 2, delete the comma.
13. On page 13, 3<sup>rd</sup> full paragraph, revise lines 4 and 5 to read ‘ ... staffing to ~~satisfactorily~~ handle anticipated licensing, inspection, reciprocity, allegations and incident response workload **satisfactorily**.’ In the last line, delete the comma.
14. On page 14, paragraph 1, next to last line, delete “staff”.
15. On page 14, paragraph 3, line 1, delete “very”.
16. On page 14, paragraph 4, last line, delete the comma.
17. On page 14, paragraph 5, line 3, replace the semicolon with a comma.
18. On page 14, last paragraph, last line, delete the comma.

The Office of Congressional Affairs should review, and concur in, all future draft letters to Congress to ensure correct distribution.
