
On January 7, 2003, the Nuclear Regulatory Commission (NRC) issued an Order requiring compensatory measures (CMs) related to access authorization for all operating nuclear power reactor licensees. Virginia Electric and Power Company (Dominion) submitted an answer to the Order on January 27, 2003 (Serial No. 03-066). Dominion's responses to CMs C.1.1, C.1.2, and C.1.3 required that Dominion provide the NRC with additional information. Attached is that information.

Additional information related to CMs C.1.4 and C.1.5 is also included in the attachment. This additional information is provided in response to a telephone conversation on March 13, 2003 with Mr. Micheal Burrell, Mr. Bradley Baxter and Mr. Christopher Gratton of the NRC. Schedule changes for CMs B.1.2, B.1.3 c), B.1.4, B.1.5, and B.1.7, C.1.6, and C.1.10 are also included in the attachment.

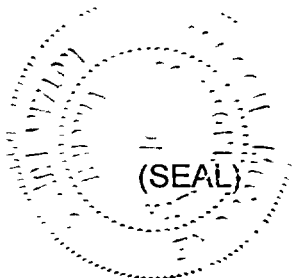
