## General:

A review of a portion of the Western Nuclear Incorporated (WNI) report entitled "Site Ground Water Characterization and Evaluation" was conducted by Mark Thaggard from a previous TAR. Mark reviewed aspects of the fate and transport model RAND3D, a random-walk model that simulates advection by moving particles along a flow path at prescribed velocities and dispersion by statistically moving particles.

The licensee has created another model for the staff's review.
