## MINUTES FROM THE MEETING BETWEEN THE U.S. NUCLEAR REGULATORY COMMISSION STAFF AND WESTERN NUCLEAR, INC. MARCH 24, 2003

On March 24, 2003, staff from the Division of Fuel Cycle Safety and Safeguards, Division of Waste Management, and the Office of the General Counsel met with representatives from Western Nuclear, Inc. (WNI) in Rockville, Maryland, in room 014 B10 at 9:00 a.m. The meeting was noticed as a public meeting on March 7, 2003 (ML030660667). No members of the public were present. This meeting was at the request of WNI to discuss their March 7, 2003, Supplemental Groundwater Modeling Report, Red Mule area issues, and surety issues. The meeting sign-in sheet is enclosed.

WNI and their consultant, MSG, gave a summary of the March 7, 2003, supplement and its conclusions. This submittal is an updated groundwater flow and fate/transport model for the southwest valley portion of the site. Since the NRC just received this report, no substantive technical discussions were conducted other than a few questions from a staff member with the Division of Waste Management regarding calibration of the model and the area that the model incorporated. Discussions were made regarding the proposed change in the long-term care boundary as related to model results. There was additional discussion regarding the Red Mule area as it relates to the new modeling results. Discussion regarding surety issues and an upcoming submittal from WNI was made. No other decisions or commitments were made.
