MEETING SUMMARY

FACILITY: MILLSTONE UNIT 2 AND UNIT 3
SUBJECT: SUMMARY OF MARCH 20, 2003, ANNUAL ASSESSMENT MEETING WITH
DOMINION POWER

On March 20, 2003, at 1:00 p.m., an annual assessment meeting was conducted at the Millstone Power Station, L. F. Sillin Jr. Nuclear Training Center on Rope Ferry Road in Waterford, CT, between the Nuclear Regulatory Commission (NRC) and Dominion Nuclear Connecticut, Inc. The NRC presented and discussed its assessment of the safety performance of Millstone Station for the period between January 1 through December 31, 2002.

The NRC presented a summary of national plant performance and discussed the annual assessment results for Millstone Unit 2 and Unit 3. An update on NRC actions to enhance nuclear plant security was also presented. At the end of the meeting between the NRC and Dominion, public attendees were offered the opportunity to ask questions of NRC officials. Questions raised by local media and concerned citizens were addressed by the NRC. There were several feedback forms submitted by the public immediately following the meeting.
