On March 27, 2003, the Commission issued Amendment No. 153 to Facility Operating License No. NPF-43 for Fermi 2 to change the Technical Specifications (TSs) in response to your application dated May 23, 2002, as supplemented December 20, 2002, and February 27, 2003. The changes revised the TSs to allow a one-time deferral of the Type A primary containment integrated leak rate test.

The purpose of this letter is to correct three typographical errors on TS Page 5.0-18, which was issued in Amendment No. 153. In TS 5.5.12.a., the phrase "Rev. O" should have been "Rev. 0," and the word "test" should have been inserted after the words "Type A." Additionally, in TS 5.5.12.d.1.(ii), the word "te" is misspelled (it should have been "the").
