5 Requirement  
 DOE/RW-0333P Rev 6, Section 1.3.1 B.2. states that "Any substantial OCRWM reorganization of descriptions or functions of the offices described herein, will require a revision to this document." Section 1.3.2 C. - E. provides the descriptions and functions for the Office of Acceptance Transportation and Integration, Office of Program Management, and the Yucca Mountain Site Characterization Office.

LP-1.1Q-OCRWM, Section 5.4 requires that a Functional Position Description is developed and maintained for each employee Attachment 2 of LP-1.1Q-OCWRM provides the functions, responsibilities, and authorities for the OCRWM organization. Specifically, Section 1.3, 1.4, and 1.5 of Attachment 2 provides the functions for the Office of Acceptance Transportation and Integration, Office of Program Management, and the Yucca Mountain Site Characterization Office respectively. Attachments 3, 4, and 5 of LP-1.1QOCRWM provide the respective organizational charts that support the OCRWM organization described in Attachment 2.

6. Description of Condition  
 Contrary to the above, the organization realignment announced on the OCRWM database to be effective on 10/28/2002, the Offices both in title and function for the Office of Acceptance Transportation and Integration, the Office of Program Management and Administration, and the Yucca Mountain Site Characterization Office described in DOE/RW-0333 and LP-1.1Q-OCRWM have been changed.

Examples of functional changes include: waste acceptance analysis & strategy, safeguards, and utility contracts are the responsibility of the Office of Systems Analysis and Strategy Development in the 10/28/2002 organization and are listed under the Office of Acceptance Transportation and Integration in DOE/RW-0333. These changes appear to violate the requirements of DOE/RW-0333.

With the position changes and creation of new positions, a Functional Position Description is not available for each employee as required by Section 5.4 of LP-1.1Q-OCRWM. For example, Functional Position Descriptions for the staff of the Office of License Application and Strategy are not available.
