As part of the GE Morris Operations application for license renewal GE Morris submitted to the NRC revision to their CSAR. This CSAR contained supplemental calculations presented on (non standard sized) Microfiche. Some of the information dates back to the original application for licensing in the late 1960's. Searches by the staff, the NRC file center and the PDR were unable to locate this information other than in the copies currently held within SFPO. In support of the current review effort copies should be placed into ADAMS
