
Exelon Generation Company, LLC (Exelon) hereby submits the following responses to the request for additional information from the above referenced letter and conference call.

I, Ronald J. DeGregorio, Vice President, do hereby affirm and state:

1. I am authorized to execute this affidavit on behalf of Exelon Generation Company, LLC ("EGC").
2. EGC is providing this information in support of its Application for License Renewal for the Peach Bottom Atomic Power Station Units 2 and 3 ("PBAPS," NRC Facility Operating License Nos. DPR-44 and DPR-56; Docket Nos. 50-277 and 50-278. The documents contained in Attachment 1P contain EGC's financial projections related to the continued operation of PBAPS. These documents constitute proprietary commercial and financial information that should be held in confidence by the NRC under 10 C.F.R. 2.790(a)(4) and 10 C.F.R. 9.17(a)(4), because:
 - i. This information is and has been held in confidence by EGC.
 - ii. This information is of a type that is held in confidence by EGC and there is a rational basis for doing so because it is sensitive financial and commercial information concerning EGC's projected operating revenues and expenses.
 - iii. This information is being transmitted to the NRC in confidence.
 - iv. This information is not available in public sources and could not be gathered readily from other publicly available information.
 - v. Public disclosure of this information would create substantial harm to the competitive position of EGC by disclosing EGC's internal financial projections.
3. Accordingly, EGC requests that Attachment 1P be withheld from public disclosure under 10 C.F.R. 2.790 (a)(4) and 10 C.F.R. 9.17 (a)(4).

Request for Additional Information

Financial Qualifications

Pursuant to 10 CFR 50.33(f)(2), the applicant shall submit estimates for total annual operating costs for each of the first five years of operation of the facility. Accordingly, the following are to be provided:

1. Exelon is requested to provide the annual projected costs for the Peach Bottom Atomic Power Station, Units 2 and 3 (the facility), for five years beginning with 2003.
2. Exelon is requested to provide the annual capacity factor for each unit for the next five years beginning with 2003.
3. In addition confirmation is requested of the following:

In the latest Projected Income Statement dated January 14, 2003, regarding Total Operating Expenses, clarify whether these costs are for the nuclear facilities only or do they include the operating costs of fossil, hydro, and any other generating assets?

Response to RAIs 1 and 2:

Exelon is providing the annual projected costs for the Peach Bottom Atomic Power Station, Units 2 and 3 (the facility) for five years beginning with 2003 in response to your request. Exelon is also providing the annual capacity factor for the facility for the next five years beginning with 2003. A redacted version of the financial qualification information is provided below. A proprietary version of the financial qualification information is provided in Attachment 1P.

Response to RAI 3:

This is to confirm that the Total Operating Expenses provided in Exelon letter to the NRC dated January 14, 2003 are for Exelon Generation, LLC as a whole, which includes nuclear facilities, fossil, hydro, and any other generating assets.
