Ms. Milicic,

I am preparing a separate response to your recent e-mail question. I hope to send that tomorrow. I also received your letter concerning the cancellation Berthold's acquisition of the Gammatrol line from Canberra. Thank you for sending it.

In addition, I have received the other two letters, the reactivation of the LB 300L gauge SSD, and the name change, that you sent in March 2003. We have no questions at this time about the LB 300L reactivation and will begin processing it.

Concerning the name change, I noticed what I believe to be a typographical error. Specifically, in the reference line, you mentioned three SSDs: NR-112-D-102-B, NR-112-D-106-B and NR-186-D-117-B. My review indicates that between Apgee and Berthold Systems Inc., there are three active SSDs issued by NRC. Those would be NR-112-D-102-B, NR-112-D-103-B and NR-186-D-117-B. Therefore, I believe you may have accidentally listed SSD NR-112-D-106-B instead of NR-112-D-103-B in the letter. Please confirm by e-mail if this is correct. We will begin processing your name change upon confirmation. Thank you.
