The purpose of this modification is to allot incremental funds in the amount of \$200,000 to the subject contract. Accordingly, the contract is modified as follows:

1. SECTION B.3, CONSIDERATION AND OBLIGATION-COST REIMBURSEMENT  
(JUNE 1988), subparagraphs b and c are replaced as follows:

- “(b) The amount presently obligated by the Government with respect to this contract is \$650,000.
- “(c) It is estimated that the amount currently allotted will cover performance through November 30, 2003.”
