

The purpose of this modification is to (1) exercise Option Year Four, thereby extending the period of performance for twelve months; (2) obligate FY2003 funds in the amount of \$174,552 for basic services and increase the firm fixed price amount of the contract from \$690,238 to \$864,790; and (3) obligate funds in the amount of \$3,650 for the ordering of on-call services. Accordingly, the contract is hereby modified as follows:

1. Section B.6 CONSIDERATION AND OBLIGATION—FIRM FIXED PRICE (JUN 1988) is deleted and replaced with the following:

The firm fixed price of this contract is \$864,790

The total ceiling amount for additional onsite elevator mechanic support for special events or functions is increased by \$3,650 to \$10,280.

The total amount currently obligated under this contract is \$875,070.

2. Section B.14 DURATION OF CONTRACT PERIOD is deleted and replaced with the following:

The contract shall commence on 5/06/99 and will expire on 5/05/2004.
The term of this contract may be extended at the option of the Government for an additional year.
