


This Modification No. 3 accomplishes the following.

- 1) corrects the Accounting and Appropriation Data in Block No. 12 of Modification No. 2 to the contract;
- 2) provides for the presentation and course materials for 11 additional workshop sessions, thereby increasing the contract ceiling by \$29,685.00 from \$112,644.00 to \$142,329.00; and
- 3) provides additional funds in the amount of \$29,685.00, thereby increasing the total funds obligated under the contract from \$112,644.00 to \$142,329.00.00.

Accordingly, the contract is modified as follows:

1. Block No. 12 of Modification No. 2, issued 1/31/03, is revised to correct the Job Code No. from "T8413" to "T8426".
2. Section B, CONTINUATION BLOCK, OPTION YEAR ONE, is modified to provide for two additional presentation and course material for the following workshops:

Overview
Contract Administration
Organizational Conflicts of Interest
Preparing Statements of Work

3. Section B, CONTINUATION BLOCK, OPTION YEAR ONE, is modified to provide for three additional presentations and course materials for the following workshops:

Independent Government Cost Estimate

4. Section B.17. CONSIDERATION AND OBLIGATION – DELIVERY ORDERS (JUNE 1988), paragraphs "a." and "b." are revised to read as follows:

"a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$142,329.00. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.

b. The amount presently obligated with respect to this contract is \$142,329.00. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the

Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a. above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

All other terms and conditions of the contract remain the same.
