Dear Ms Beckman:

This confirms the verbal authorization that was provided to you on April 4, 2003, with a temporary ceiling of \$3,856.39. The purpose of this modification is to increase the level of effort for Mr. Brothers by ten hours, from 224 hours to 234 hours, and to add one five-day trip to the site for Mr. Brothers. As a result of these changes, the task order ceiling is increased by \$3,772.35, from \$115,172.73 to \$118,945.08. The obligated amount is increased by \$18,945.08, from \$100,000.00 to \$118,945.08, thereby fully funding this task order. Accordingly, the following changes are hereby made:

"Task Order No. 148 shall be in effect from March 28, 2003, through May 30, 2003, with a cost ceiling of \$118,945.08. The amount of \$115,282.44 represents the estimated reimbursable costs, and the amount of \$3,662.64 represents the fixed fee. This task order is fully funded."
