

The purpose of this modification is to provide incremental funding under the contract in the amount of \$670,000.00 for the payment of utility services (\$650,000) and reimbursable services (\$20,000). The obligated amount for utility services is increased from \$5,834,107 by \$650,000.00 to \$6,484,107. The obligated amount for reimbursable services is increased from \$468,833 by \$20,000 to \$488,833. Accordingly, the contract is modified as follows:

Paragraphs B and E under Section B.5 TOTAL ESTIMATED COST FOR UTILITIES AND REIMBURSABLE SERVICES are modified to read as follows:

- B Total funds in the amount of \$6,484,107 have been obligated for the payment of utility services for the base and option periods.
- E Total funds in the amount of \$488,833 have been obligated for the performance of reimbursable work for the base and four option periods.

Paragraph D under Section B.6 CONSIDERATION AND OBLIGATION - FIRM FIXED PRICE is hereby modified to read as follows:

- D. The total ceiling amount for the Firm Fixed Price services (\$962,136), reimbursable contract services (\$100,000), and payment of utilities (\$1,800,000) for Option Year 4 is \$2,862,136. The total amount obligated for these services for the final option period is increased by \$670,000 from \$1,036,420.00 to \$1,706,420

This modification obligates FY03 funds in the amount of \$670,000.00.
