By letter dated July 2, 2001, Exelon Generation Company, LLC, submitted its application to renew the operating licenses for Peach Bottom Atomic Power Station, Units 2 and 3. The staff reviewed the license renewal application in accordance with 10 CFR Parts 51 and 54. Region I also performed three inspections, as described in a February 14, 2003, memorandum from Hubert Miller, Regional Administrator. The staff documented the results of its safety review in its "Safety Evaluation Report Related to the License Renewal of Peach Bottom Atomic Power Station, Units 2 and 3," which was published as NUREG-1769 in March 2003.

With respect to environmental matters, the staff documented the results of its reviews in a supplemental environmental impact statement which was published as NUREG-1437, "Generic Environmental Impact Statement for License Renewal of Nuclear Plants, Supplement 10, Regarding Peach Bottom Atomic Power Station, Units 2 and 3," January 22, 2003.

Pursuant to the June 5, 2002, staff requirements memorandum on SECY-02-0088, the Director of NRR issued Renewed Facility Operating License Nos. DPR-44 and DPR-56 for Peach Bottom Atomic Power Station, Units 2 and 3, on May 7, 2003.
