

The purpose of this modification is to provide incremental funding in the amount of \$30,000.00, thereby increasing the obligated amount of the contract from \$487,000.00 to \$517,000.00. Accordingly, the contract is hereby modified as follows:

Under Section B.4, "CONSIDERATION AND OBLIGATION--WORK ORDERS," the second sentence in paragraph "(b)" is revised to read as follows:

"(b) The amount currently obligated is \$517,000.00."

All other terms and conditions of the contract remain unchanged.
